We've received an overwhelmingly positive response and with the upcoming winter season, we look forward to providing the weather forecasts to keep our listeners informed and safe.




Have you maximized your tax deductions?

- Avoid the year-end giving by setting up an automatic one-time, monthly or quarterly withdrawal from your checking account using your bank's online bill pay system. Check with your bank for details.
- A "Gift of Stock" may be right for you. Charitable contributions of appreciated stock give you two income tax advantages. For long-term capital gain property (stock held more than 12 months) the first is a charitable deduction equal to the full fair market value of the gifted property, up to 30 percent of your adjusted gross income. The second advantage of giving stock is that you will also avoid capital gains tax, money you would have to pay if the property was liquidated first.
